CERTIFICATE OF ELIGIBILITY (I-20) APPLICATION

WSC cannot process your Certificate of Eligibility (I-20) until all Financial Support Agreements and documentation have been received. **Note:** If you are currently studying in the U.S. and would like to transfer your visa to WSC, please complete the International Student Transfer Form in lieu of this form.
